NEWLAND DEVELOPMENT ORDINANCE (NDO)

REVIEW OF DRAFT ARTICLES

Vice-chair Foxx asked about the article on the state of emergency. Rick used the town of Andrews as an example to clarify what a state of emergency entailed.
